



Overview of COVID-19 hygiene measures at the CECP 2022  
from February 13<sup>th</sup> to 17<sup>th</sup> 2022 in Bad Hofgastein  
version 1.0, 07.01.2022

**Entry from abroad:**

**Accommodation:**

Your accommodation will also require a valid 2G proof when checking in.

**Admission to the conference:**

Your 2G proof will be verified on Sunday afternoon or evening when you first enter the conference venue. This will require a valid EU certificate and an identity card. The verification will be carried out using the "GreenCheck-App". You are kindly requested to check your QR code beforehand using the app with the setting 2G. Access to the premises will only be granted if your certificate is valid and you will receive your CECP name badge, which must be worn at all times. The authorities and the police can carry out inspections at any time, so you will need to carry your 2G certificate and an ID card with you at all times. Between Monday and Wednesday, your name badge will be sufficient to access the premises. It must not be passed on to anyone else or modified. The use of hand sanitizer is recommended when entering the building.

In the event of any symptoms of illness, or a positive COVID-19 test, you may no longer attend the meeting and the appropriate health regulations will apply.

**At the conference:**

In addition, FFP2 masks are mandatory. The masks must be worn at all times and may only be taken off at your assigned seat for the consumption of food and beverages. Speakers are also allowed to speak without a mask during their presentations. The conference premises are closed to the public. All attendees should leave the conference center by 10 pm at the latest.

**In the auditorium:**

There are allocated seats with numbers (registration number) and names (first and last name, city). You must always use your assigned seat and changing seats is forbidden. An overview map can be found in the entrance area.

**Cleaning:**

The conference premises will be cleaned on a daily basis. In addition, all surfaces in the auditorium will be disinfected by electrostatic cleaning. Sufficient hand disinfection facilities are available throughout the premises.

**Coffee break and evening buffet:**

Food and beverages may only be consumed at the seats outside the lecture hall. You can choose your seat. There will be registration forms at the table. We would like to ask you to enter your name at each coffee break or evening dinner. The food will be served in the lobby at a designated place. As a general rule, there will be no self-service of unpacked food or beverages. During the evening dinner, you can order alcoholic drinks from the personnel of the caterer. It will be served at your seat and have to be paid individually.

The bar in the Kurparkhotel is not accessible for participants of CECP 2022.

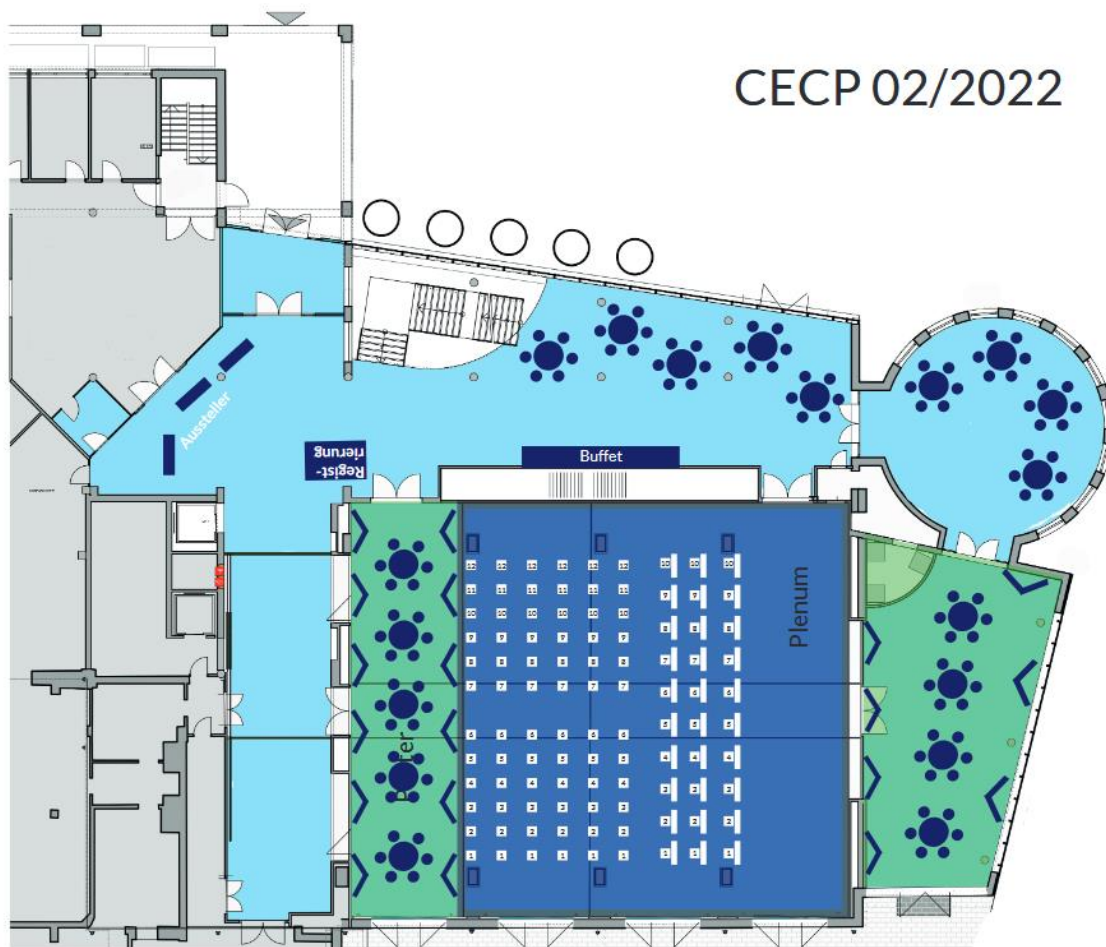
**Contact Tracing:**
